APPENDIX I-Poard Pledge

Amendment to Bylaws

New Bylaws may be adopted or these Bylaws may be repealed or amended at a Board meeting by a majority vote of the members of the Board attending thereat. Thirty (30) days advance written notice must be given for consideration of amendments to the Bylaws.

Whenever an amendment or new by-law is adopted, it shall be copied in the book of Bylaws with the original Bylaws, in the appropriate place. If any of the Bylaws is repealed, the fact of the repeal with the date of the meeting at which the repeal was enacted shall be stated.

The Board shall review its Bylaws at least once every three years.
