Review proposal to increase height of tower for radio antennae and add wifi antennae for CTEC community

Discuss proposals to spend HEERF I and II funds.

Agenda/Major Topics of Discussion:

Proposal to increase height of tower for college radio antennae and add wifi antennae would strengthen communication abilities for COVID-19 and other announcements from the college as well as expand the boundaries of wifi access around CTEC. VPEMSS made a motion to endorse; Dir. IT seconded the motion, and cabinet voted unanimously to endorse the proposal.

There are still large amounts available from HEERF I and II funds. Student portion is another \$1.8m and the second award for the institution is \$4.9m. The college needs to spend the remaining \$1.8m from HEERF I.

- Reimburse the college for hazard pay from first lock down
- Reimburse college for lost revenue in the residence hall and dining hall
- Reimburse college for paying student's way home during first campus closure
- Reimburse college for additional security and overtime
- Compensate faculty for training from CANVAS
- IT to put together list of all equipment, computers, and accessories to upgrade all campus labs and classrooms for online learning.
- Invite Pohnpei students to stay in residence halls during the week at modified rate (to be determined by Business Office)
- HEERF II Student Portion (\$1.8m) Disburse the same as first time prioritizing Pell Eligible students; according to credits taken; enrolled spring 2021. Student Services to provide official enrollment list.
