

College of Micronesia-FSM We Care Student Aid

Introduction

The College of Micronesia-FSM We Care Student Aid is intended to support students facing financial hardships due to the COVID-19 pandemic. This aid provides the selected students the supplemental financial assistance to cover outstanding (or unpaid) tuition and matriculation fees, including on-campus room and board fees after all federal grants and national and state scholarships are applied.

This student aid must be applied to the recipient's outstanding balance on tuition and required matriculation fees (e.g., housing, transportation and books) at the college for the academic term beginning spring 2020.

Eligibility Requirements

To be eligible for consideration, applicants must be:

- 1. Be a continuing or returning student at COM-FSM in the Spring of 2023.
- 2. Enroll in an undergraduate program of study as a full-time student at COM-FSM in the Spring of 2023. Graduating students may be considered depending on the required credits needed to graduate.
- 3. Have incurred outstanding (or unpaid) balance at COM-FSM on tuition and required matriculation fees, including oncampus room and board fees during the spring 2020 to fall 2020 terms.
- 4. Make use of the college's student support services such as tutorial in lieu of withdrawing from classes.
