Discussion of Agenda/Information Sharing:

- 1. **Call to Order; Declaration of Quorum**: President Daisy opened the meeting at 1:05 PM. A quorum was declared.
- 2. **Reading of the Mission Statement**: Dean Roboman read the mission statement.
- 3. **Review of Agenda**: Since BP 7007 was just disseminated, VP Habuchmai suggested taking it off the agenda for review and possibly electronic voting.
- 4. **Approval of Minutes:** VP Oducado moved and VP Habuchmai seconded to approve the minutes of the November 16, 2018, meeting as presented. The motion passed.
- 5. Old Business none
- 6. New Business
 - a. VPAS
 - i. **Review of Fiscal Policies** Twelve policies were presented; of which, three had no recommended change; two were recommended for deletion; and the others had minor revisions. Changes and the reasons for the revisions were pointed out. Recommendations were made to follow the publication manual, to use numbers rather than bullets, and to have separate slates for no changes, elimination and revisions when presenting the policies to the board. *VP Simion*

moved and Director Jack seconded to endorse the recommendations to endorse the revisions to BP 5109 Imprest Fund, BP 5330 Payroll Policy, BP 5331 Attendance and Leave Monitoring Policy, BP 5601 Establishment of Accountability and Movement of Assets, BP 5700 Bookstore Operation Policy, BP 5721 Dining Hall Operation Policy; the review of BP 5105 Receipt of Cash and Collection Policy, BP 5106 Petty Cash, BP 5500 Financial Reporting, BP 5607 Non-Payment for Plants, Trees, Crops Planted on College Property; and elimination of BP 5302 Processing of Purchase, and BP 5303 Processing Payment Policy. The motion passed.

Dr. Daisy explained about the misunderstanding with BP 5608; the issue is with the procedure and not the policy. Action is not needed on the policy, however the AP needs work. VP Kocel moved and VP Oducado seconded to suspend AP 5608 until a revised procedure is approved. The motion passed.

- ii. Review of Human Resources Policies Three policies and one procedure were presented; one policy is a review with no recommended change, another is a new policy, and third includes revision to Section 11.d on acting compensation. VP Habuchmai moved and VP Oducado seconded to endorse the review of BP 6022 Employee Organization and the new policy BP 6034 Professional Dress Guidelines with minor change. The motion passed.
 - VP Simion moved and VP Habuchmai seconded to table AP 6034 for further work. The motion passed.

The rationale for the changes to BP 6009 was shared. Discussion followed on how the changes would be implemented. VP Kocel moved and VP Oducado seconded to table BP 6009 for further work. The motion passed.

iii. Emergency Management Plan – Revision of the EMP started last summer and has received board review. Once approved, next steps include signage and fall out area maps to direct people during emergencies. VP Simion moved and VP Kocel seconded to endorse the revised EMP after a final edit. The motion passed.

b. VPIA

- i. Inclusion of BS Related Policies With approval of the BS degree in elementary education, a review was made of policies to be BS inclusive. Eight policies needed revisions and two new policies were created. VP Habuchmai moved and VP Oducado seconded to endorse the new polices (BP 1530 Baccalaureate Programs and BP 4210 Admission to 4th-Year Bachelor of Science Degree in Elementary Education) and revisions to BP 1110 Assessment, BP 1500 Roles of Campuses, BP 3001 Catalog Limitations, BP 3101 Academic Program Requirements, BP 3202 Instructional Program Review, and BP 4204 Admission to Third-Year Certificate of Achievement Program in Teacher Preparation-Elementary as revised. The motion passed.
- ii. Review of Instructional Policies Four policies were scheduled for review; only BP 3119 was revised, the other three had no recommendation for change. VP Oducado moved and VP Habuchmai seconded to endorse the recommendation to endorse the review of BP 3116 Academic Honesty, BP 3117 Withdrawal of Students for Absences, BP 3118 Credit Load and Overload, and the revision to BP 3119 Credits. The motion passed.

c. President

i. Board of Regents Meeting – The schedule for the week of the board meeting is Kosrae was shared which is packed with activities involving the vice president and deans. Invitation was extended to Dean Mike to include some of his staff in the refresher course. Problems with the schedule should be reported to the president or Norma.

- ii. Outdated Info on Web Site A mechanism is needed to keep the website updated. All were tasked to go over the website and report outdated information.
- 7. Miscellaneous
 - a. **Retirement Plan** VP Habuchmai explained the proposed changes to the retirement plan. All were asked to vote electronically on the proposed changes.
- 8. **Adjournment**: *VP Habuchmai moved and VP Simion seconded that the meeting be adjourned.* The meeting adjourned at 2:33- PM.
